## ROAD CLOSURE BYLAW 2021-282.1

A Bylaw of the Village of Hill Spring, in the Province of Alberta for the purpose of closing public travel and consolidating to adjacent title(s), a portion of undeveloped road as per highlighted section of Schedule 1 - Sketch Plan showing road closure area within Block 25, Plan 370BD, portions of a public road in accordance with Section 22 of the municipal Government Act, Chapter M26.1, Revised Statutes of Alberta 2000, as amended.

**WHEREAS** the lands hereafter described are no longer required to public travel, and

**WHEREAS** application has been made to Council to have the laneway closed, and

**WHEREAS** the Council of the Village of Hill Spring deems it expedient to provide for a bylaw for the purpose of closing to public travel certain roads, or portions thereof, situated in the said municipality, and therefore disposing of same, and

**WHEREAS** notice of the intention of Council to pass a bylaw has been given in accordance with Section 606 of the Municipal Government Act, and advertised beginning August 11, 2021 electronically and physically, and

**WHEREAS** Council was/was not petitioned for an opportunity to be heard by any person claiming to be prejudicially affected by the bylaw


**NOW THEREFORE BE IT RESOLVED** that the Council of the Village of Hill Spring in the Province of Alberta does hereby close to public travel for the purpose of consolidating to adjacent title(s) the following: see attached Schedule 1 - Sketch Plan Road Closure Area within Block 25, Plan 370BD, subject to rights of access granted by other legislation:

Excepting thereout all mines and minerals.

1.1. This bylaw shall come into effect upon passing of third and final reading.

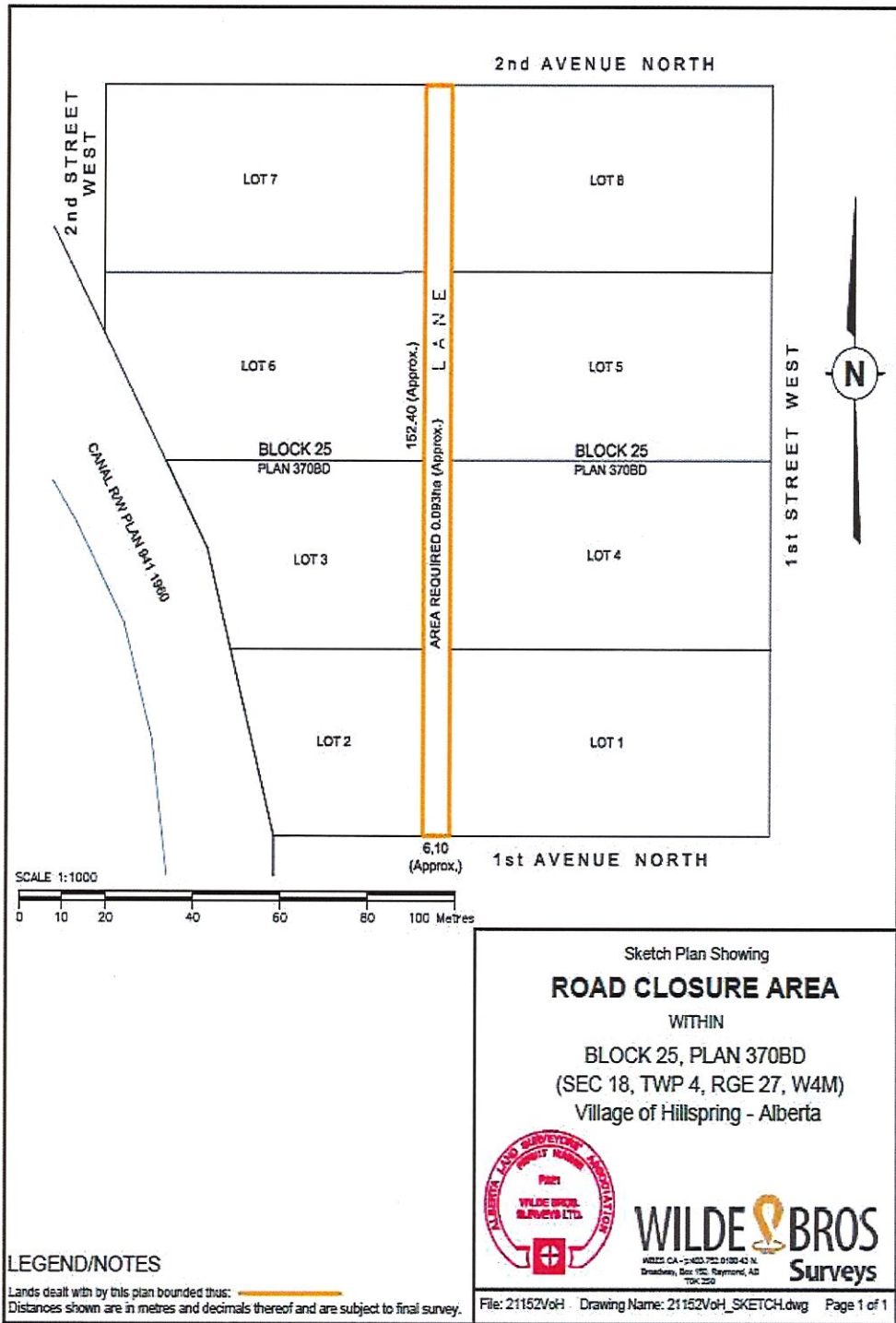
