ROAD CLOSURE BYLAW 2021-282.2

A Bylaw of the Village of Hill Spring, in the Province of Alberta for the purpose of closing public travel and consolidating to adjacent title(s), a portion of undeveloped road as per highlighted section of Schedule 1 - Sketch Plan showing road closure area within Block 15, Plan 370BD, portions of a public road in accordance with Section 22 of the municipal Government Act, Chapter M26.1, Revised Statutes of Alberta 2000, as amended.

WHEREAS the lands hereafter described are no longer required to public travel, and

WHEREAS application has been made to Council to have the laneway closed, and

WHEREAS the Council of the Village of Hill Spring deems it expedient to provide for a bylaw for the purpose of closing to public travel certain roads, or portions thereof, situated in the said municipality, and therefore disposing of same, and

WHEREAS notice of the intention of Council to pass a bylaw has been given in accordance with Section 606 of the Municipal Government Act, and advertised beginning August 11, 2021 electronically and physically, and

WHEREAS Council was/was not petitioned for an opportunity to be heard by any person claiming to be prejudicially affected by the bylaw

NOW THEREFORE BE IT RESOLVED that the Council of the Village of Hill Spring in the Province of Alberta does hereby close to public travel for the purpose of consolidating to adjacent title(s) the following: see attached Schedule 1 - Sketch Plan Road Closure Area within Block 15, Plan 370BD, subject to rights of access granted by other legislation:

Excepting thereout all mines and minerals.

1. DATE OF COMMENCEMENT

1.1. This bylaw shall come into effect upon passing of third and final reading.

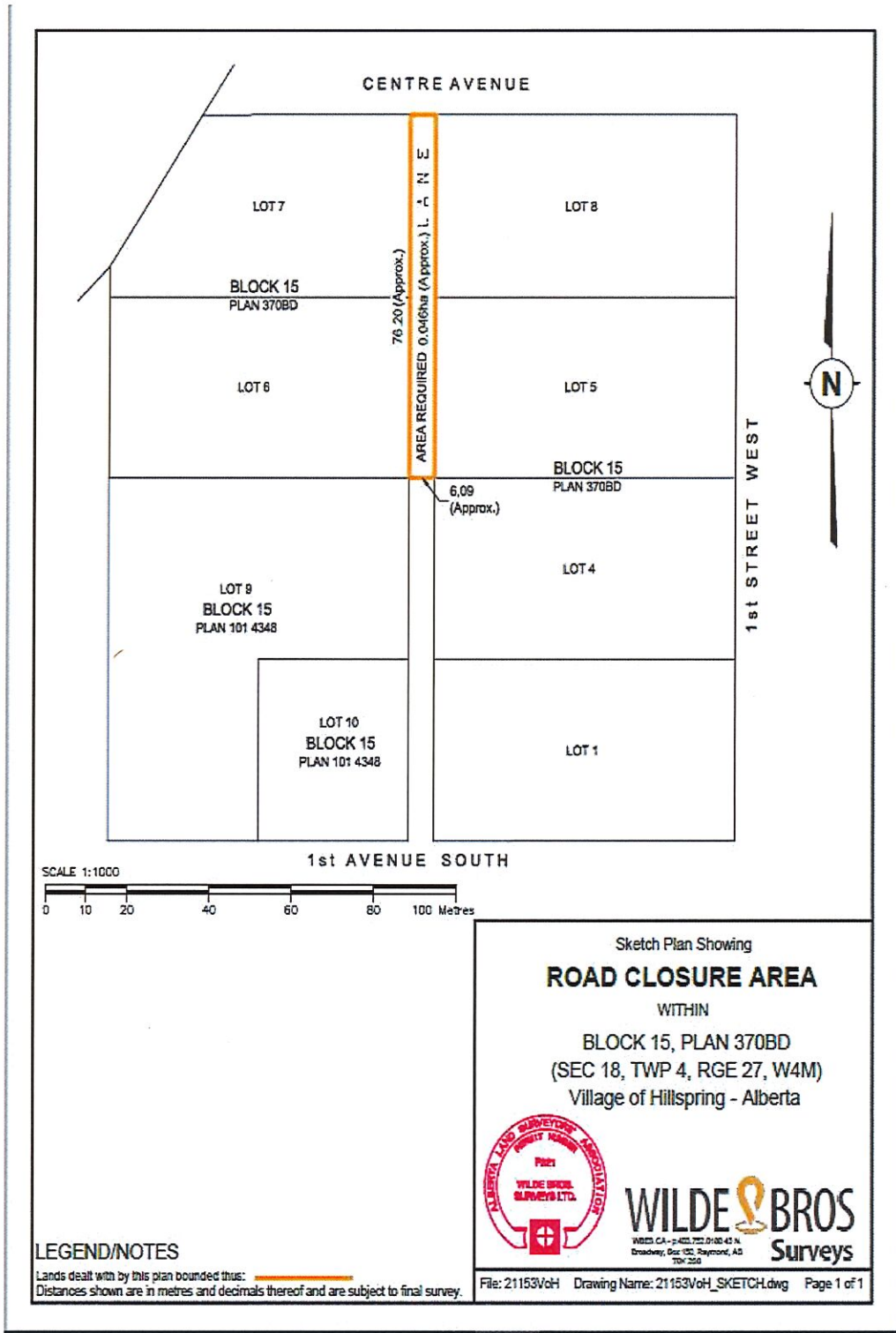
