# VILLAGE OF HILL SPRING COUNCIL

2022 Taxes: Tax notice/assessments were mailed out on May 31, 2022. If you have not received your tax notice please drop by the office to pick up a copy. Please note that taxes are due July 31, 2022. Any taxes remaining unpaid after the due and payable date will receive a 12% penalty on Aug. 1, 2022. A 1.5% will be imposed on the total unpaid balance of the tax accounts and applied the 1st day of each calendar month.

Village utilities for May/June were mailed out on Monday, July 4 and are due on Aug. 8, 2022.

The Intermunicipal Bylaw 2022-322 was given third and final reading and passed at the June 21 regular council meeting. This Intermunicipal plan is a plan between Cardston County and the Village of Hill Spring.

The Village council made a resolution to use Oldman River Planning Commission (ORRSC) to prepare an updated Land Use Bylaw. The goal is to have the bylaw completed by or before year end.

The following building permits were issued in June:

2022.R1.04.DP—Lot 2 Block 21 Plan 0614153 - development of a shed;

2022.C2.06 DP Lot 4 Block 7 Plan 370BD - waiver on an existing building;

2022.C2.04 DP Lot 1 Block 7 Plan 370 BD—permit to build a home.

Please note that if you are doing any development whether it be building or changing the use of the property you need to apply for a development permit. Any accessory building bigger than 100 sq. ft. requires a permit.

Village Manager, Janet Edwards, will be out of office the remainder of July. Patti Faulkner will be working in the office.

## **LONG GRASS**

According to Bylaw 2018-297 it is the responsibility of all land owners to keep the grass mowed on their property and the adjacent boulevard.

"Property owners are to maintain grass on their lots at a length of fifteen (15) centimeters (six (6) inches) or less;

Property owners are to maintain all grass on their lots at a length of twenty-five (25) centimeters (ten (10) inches) or less;

Boulevards are to be kept mowed and in a tidy condition by the owners of the adjoining property."

When boulevards are mowed and tidy, it improves the aesthetics of the entire neighborhood.
